

### **On-Programme Learning**

During the 15-month on-programme learning period, you will compile a comprehensive portfolio. This portfolio will demonstrate your development and proficiency in the key responsibilities of a Golf Greenkeeper:



Introduction to Golf Course Maintenance



Health & Safety Regulations and Practice



Turfgrass Identification & Management



Mowing and Aeration Techniques

Fertilisation and Top Dressing



Equipment Maintenance and Repair

#### Months 15-18

### **End Point Assessment**

Upon successful completion of the on-programme learning, you will undergo a comprehensive final endpoint assessment designed to showcase your development throughout the programme. This assessment consists of three components:

#### **Knowledge Test**



The knowledge test will examine criteria that may not naturally occur during everyday business activities. It is important for learners to demonstrate knowledge recall and understanding. The test will be computer or paper based and will consist of 50 multiple-choice questions.

The observation allows for practical testing of knowledge, skills and behaviours holistically. The independent assessor will observe the apprentice undertaking work under controlled conditions. The practical assessment and questions must take 3.5 hours and will test specific areas of the assessment criteria.

#### **Professional Discussion**

The professional discussion supported with a portfolio and the supplementary questions is carried out during a facility walk will last 90 minutes in total and consist of 2 parts. The first part will take place in a room free from distractions and the second part will take place alongside a facility walk.
